The "We Honor Veterans" program offers an added level of care, beyond the traditional hospice role, that we can provide.

For us at Tidelands Community Hospice, it is an honor to be chosen by a family to care for their loved one at the end of life. We are privileged to provide care and comfort to the patient, support to their loved ones and to join them in the last chapter of their life journey. It is our belief that no one at the end of life, regardless of their financial status or life situation, should be without care. No one should be without the smallest of life's necessities. No family should be without support. Serving as the only locally based and governed not-for-profit hospice provider in Georgetown, Horry, and Williamsburg Counties, we turn no one away.

Thus far this year, we have provided hospice care to over 213 patients and families. Rarely does Medicare, Medicaid, or private insurance cover the cost of providing hospice care. Not all patients are eligible for Medicare, Medicaid, or private insurance. Others need aid with basic daily necessities, situations beyond daily needs, and supplies. Your gift helps ensure that care, beyond the traditional role, comfort and support is available to all at a time when every moment counts.
